Annual Pro Forma Budget & Policy Disclosure – Discussion/Possible Action

On page 2 paragraph, 2 It says that the reserve funding disclosure summary, which was completed by associate reserves pursuant to Civil Code Section 5570.

That is an error. The associate reserves are the people who did our 30-year reserve study last year. We're required to use a third party to do our reserve study every 3 years.

So, this year it was done in-house and I prepared that so what I'd like to suggest is that we just take out the words by association reserves and leave the sentence as a reserve funding disclosure summary which is completed pursuant to civil code Section 557O.

We are not required to use an outside agency to do the reserve study every year. 2022 was done by Dorothy, Kim, and Dave.

Shelly clarifies one item amount on the budget - \$\$ is for resurfacing not replacement of the pool.
